### Rules

- Entry Fee: \$50.00 per boat  
Entry fee & Sign Up Form can be mailed in, or paid at Blue N Hall Marina  
\$100 Sponsorships paid include boat entry
- Capt. Meeting: Optional information meeting @ Blue & Hall Marina; May 4th at 6:00pm.
- Location: Boats can leave from any location. **If you are driving in, you must register no later than May 4th.** Weigh-in will be on the dock at Blue & Hall Marina. Catch may be brought in by car, truck or boat.
- Time: Fishing time begins at daylight. You must be back to the dock by 3pm.  
  
Fish fry afterwards (\$10 for non-fisherman) - fish, fries & slaw.  
Members of McIntosh Rod & Gun Club will be frying the caught fish & will be serving food starting at 2:30pm.
- Species: Whiting (no creel limit, no size limit)
- Weigh In: Is from 12-3PM. All fish accepted for weigh-in must be caught on Tournament Day, un-mutilated, in fresh, edible condition, and available for inspection. Weigh up to, but no more than 10 Whiting. All fish weighed become the property of the tournament. In case of a tie, the fish that were weighed in first win. Fish must be taken by Rod & Reel. Only one prize will be awarded per boat. Decisions of the Tournament Committee are final.
- Communications: The VHF-FM tournament frequency will be channel 16.
- Prizes: The Awards will follow weigh-in  
Payout based on # of boat entries. Minimum \$250 for 1<sup>st</sup>, other places based on number of entries
